#### **NEW BUSINESS**

## 2013 GMC Front Tire Replacement: Cl'm Fickes

Newport Auto Repair LLC, Newport, inspected the 2013 GMC on 9/6/24 and made a recommendation at that time to have the 2 front tires replaced at a cost of \$240.00 per tire, which included mounting and balancing. The truck did pass inspection.

A verbal quote of \$204.00 per tire was obtained from Deimler's Tire Service, 7297 Spring Road, Sherman's Dale, PA 17090 for a medium grade tire. Tabled. Will obtain a written quote and bring back to the October 1, 2024 Council Meeting.

## **PUBLIC COMMENT:** Evan Wise:

Mr. Wise made a disclaimer that he was not affiliated with any borough organization as he addressed the safety concerns of the children leaving the elementary school, crossing the roadway, and himself witnessing many near misses caused by vehicles not obeying the posted stop signs. The new gym on Fickes Lane is creating more foot traffic on Brick Avenue after school. The State Police have been asked to check the area between 3 pm -4:30 pm. Mr. Wise continued his concern for safety of the children with, in his words, the park and streets being riddled with drugs. He suggested the borough add a stop sign on the left side of the road to increase safety.

Cl'm Fickes will speak to the streets crew about supplies that would help with the situation.

## **PUBLIC COMMENT (continued):** Frank Campbell (NRPS):

The collaborative effort between the Perry County Chamber of Commerce and the Perry County Economic Development Authority (PCEDA) was instrumental in spearheading the first Discover Perry County Pennsylvania 2024 brochure that grew to 80 pages. Great job! Thank you to Newport Borough for participating in this endeavor with Newport Revitalization Preservation Society (NRPS).

# HEARING 7:15 pm: Request for transfer of Liquor License from Newport Tavern LLC, 726 North 4<sup>th</sup> Street, Newport , PA, Oliver Twp., Perry County to Newport Convenience, 29 N. 2<sup>nd</sup> Street, Newport Borough, Perry County

Attorney Dave Rossi swore in Ansh Shah to give testimony on his background and aspirations for his new business endeavor, Newport Convenience, requesting the transfer of the liquor license from Newport Tavern, LLC, Oliver Twp., Perry County to 29 N. 2<sup>nd</sup> Street, Newport Borough, Perry County.

## Ansh Shah: Background

- 21 years old, Senior at Penn State, active in Philanthropy Committee, lives in Cumberland County
- Parents, Nikul and Bola Shah, have had businesses in Shermans Dale, Loysville, and Tower City.
- Parents gave back to the communities where their businesses were, and the son would like to do the same.
- Father has been in business for 30 years: Never had a citation, trained employees for no underage access.
- Son would like to start his own business: Newport Convenience

## Ansh Shah: Newport Convenience, 29 N. 2<sup>nd</sup> Street, Newport Borough

- Convenience store, small deli, seating for 32
- Community gathering place
- Convenience items in front; Deli and alcohol in back
- Convenience section will carry cigarettes and tobacco products, but no smoking is permitted on premises
- Deli would prepare food on-site; Patrons sit where they would like; No table service
- $\bullet$  8 10 tables, some high-top tables to give allusion of roominess; Floor plan of seating not available at this time
- Not a bar: no tap beer; no hard liquor; Note that an R-license designates Restaurant, which these alcohol items would be allowed; R-license requires seating for 30
- Standard and craft beers would be available for eat-in or package goods to go
- Hiring 15-20 employees
- Hours: 9 am 8 pm, 7 days a week
- Possible outdoor seating in the future
- \$38,000 has been invested in the property for a building he does not own

#### Council Comments

- Some did not want to see just another bar in Newport
- Some liked the idea of an eatery offering craft brews
- Some remember when there were 3 bars in Newport and not having a problem in the past
- Once a liquor transfer is within Newport Borough, the liquor license can transfer within the borough without borough council having any say, but all the Liquor Control Board (LCB) rules must be followed
- A vacant store front will now be occupied
- More thriving businesses might give a reason for buying a home in Newport
